### Schools Christmas Hamper Giveaway Competition 2019

1. The promoter is 'Robert Price (Builders' Merchants) Ltd', Company No. 1235332, whose registered office is Park Road, Abergavenny, NP7 5PF.
2. The competition is open to any registered Primary School, within our branch network area of 'South Wales, United Kingdom'. The competition entry submission must be completed by an individual aged 18 years or over. Employees of Robert Price (Builders' Merchants) Ltd, and any individuals involved in judging the competition are excluded from entry.
3. There is no entry fee and no purchase necessary to enter this competition.  
(There is no additional charge placed on goods to qualify for entry.)
4. The route to entry for the competition and details of how to enter can be found on the Robert Price website (Promotions Section). This competition will be promoted on the following social media platforms: Facebook, Twitter.
5. Only one entry will be accepted per person, per school. Multiple entries from the same person or school will be disqualified with only the first entry being considered.
6. The closing date for entry will be: Tuesday 10<sup>th</sup> December 2019 at midnight. After this date and time, no further entries to the competition will be accepted.
7. No responsibility can be accepted by the promoter for entries not received for whatever reason. This includes email / internet system failure or postage failure.
8. The rules of the competition and how to enter are as follows:  
Primary Schools within the 'Robert Price' branch network area are eligible to enter a 'story' into our Christmas Hamper Giveaway Competition, it must detail: what it would mean to win the prize and how the supplies would be used. Robert Price is giving away 2 hampers of school arts and crafts supplies, to 2 separate winners. 2 winners will be drawn from all submissions entered. Entrants will only be eligible to win a maximum of 1 prize. No school can win more than 1 hamper prize. 14. The winner will be notified by email and/or phone call within 7 days of the closing date (10<sup>th</sup> December 2019). If the winner cannot be contacted or does not claim the prize within 7 days of notification, the promoter reserves the right to withdraw the prize from the winner and pick a replacement winner.
15. The promoter will notify the winner, either by phone or email, of when and where the prize can be collected or where it will be delivered.
